Can you describe and/or demonstrate the specific impact that TFN funding has had against your initial objectives?	The aim of the project was to hire and train a Programme Manager who can manage and lead on Settle's delivery operations. We successfully recruited our Programme Manager, Aimee Hardaker, who joined us from Frontline in June 2019.
	This has had a transformational impact on the organisation and has allowed us to implement our scaling plans effectively. Previously, our CEO spent ½ of his time managing programme delivery which included everything from managing the delivery team to managing referral partnerships and reporting on programme outcomes.
	Our Programme Manager now leads on these responsibilities and is able to provide the support the team and programme needs to maintain its quality outcomes for young people. She currently manages our team of 3 Programme Officers, manages our partnerships with local authorities and housing associations and leads on our evaluation work.
	As a result, our CEO has had significantly more time to focus on our strategic objectives, income generation and growing the organisation.
